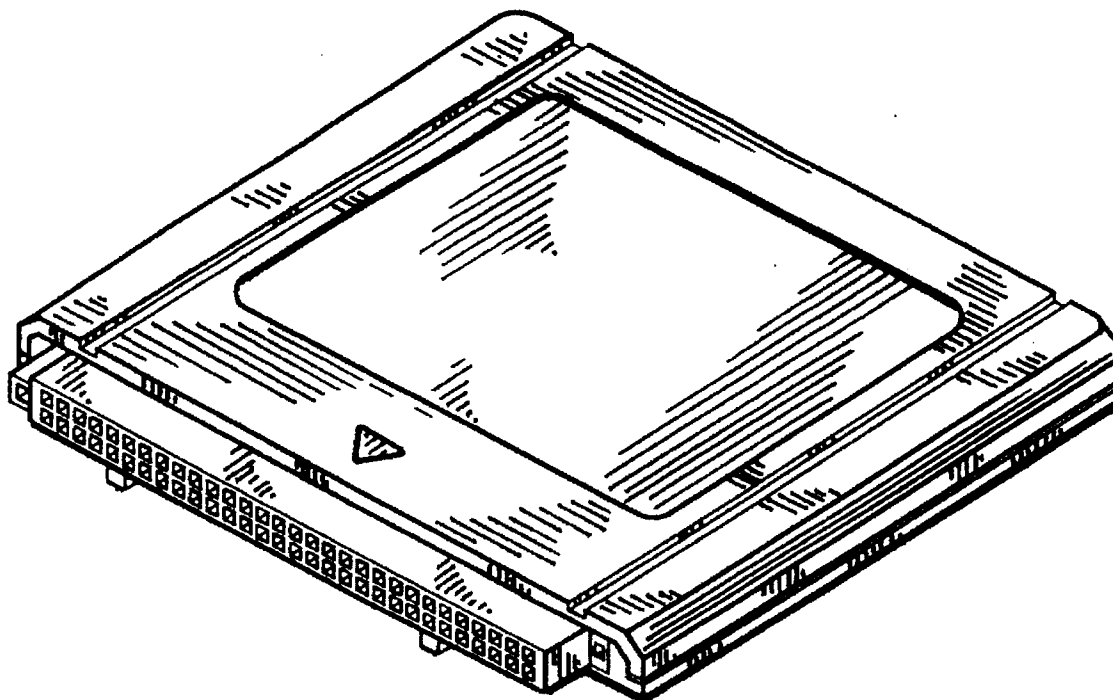
FIG. 1 is a top right front perspective view of a game cartridge showing our new design;

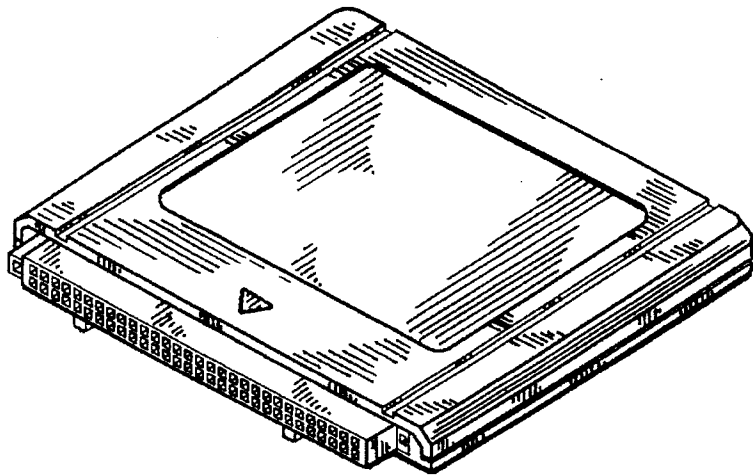

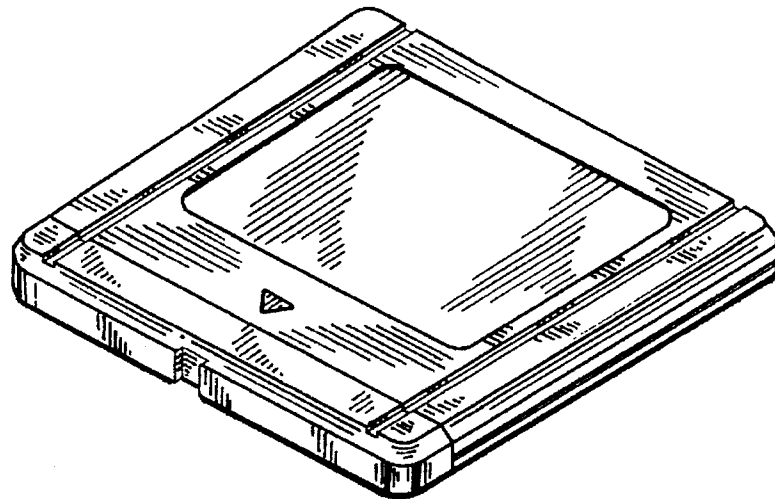

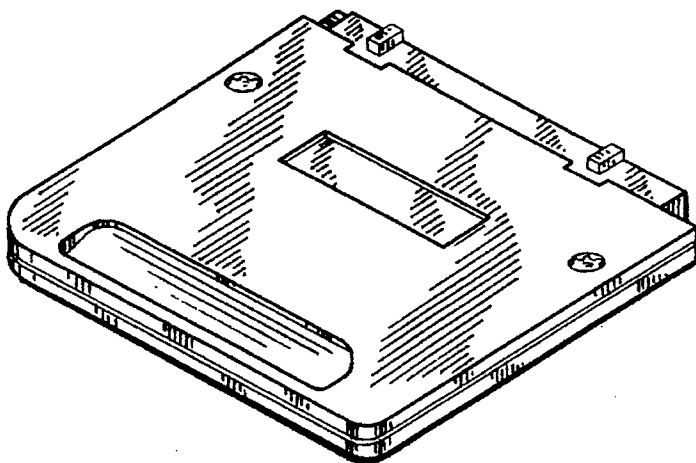

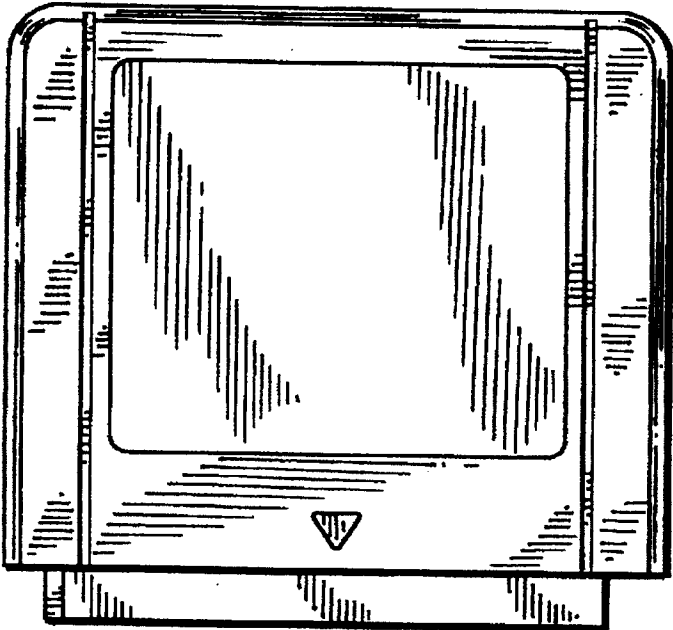

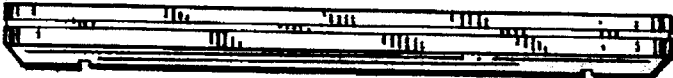

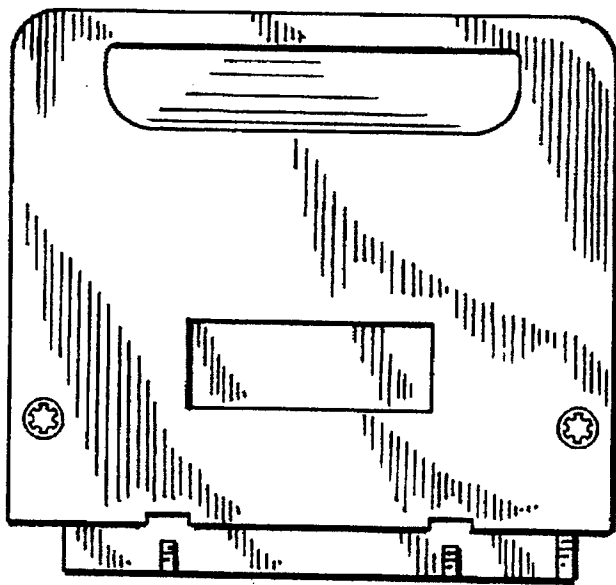
